On May 2, 2019, the Ventura County Grand Jury completed a **Drugs and Sharps** *Final Annual* for the County of Ventura. This included website research regarding drug bin disposal programs in the County as well as on-sites at local law enforcement agencies. The Grand Jury visited the Port Hueneme Police Department located at 250 North Ventura Road and verified drug bin availability along with accessibility and procedures. The Grand Jury found the Port Hueneme Police Department needed to update their websites and other forms of communication to better inform the public about their existing drug-disposal programs.

The Ventura County Grand Jury noted several areas for improvement and made the following <u>Conclusions and Recommendations</u>:

**C-01:** The Grand Jury concluded that among the County law enforcement facilities that have drug disposal bins, there is a lack of information and consistency in public guidance regarding disposal of all medications, particularly for pet owners. (FA-09, FA-10, FA-11, FA-12, FA-13, FA-14, FA-15, FA-16)

#### **GRAND JURY RESPONSE - EXHIBIT A**

#### PRESCRIPTION/MEDICATION TAKE BACK PROGRAM



Do you have expired, unused or unwanted medications? The Port Hueneme Police Department has two secure pharmaceutical drop off bins in the lobby to divert harmful drugs away from children, the environment, and potential abuse in our community. The goal is to allow Port Hueneme residents a safe alternative to deliver all unused, unwanted, or expired medication to local law enforcement officials, who can in turn dispose of these controlled substances in a safe, secure, and non-hazardous manner. This program is not intended for commercial use and is not in place to assist pharmacies or hospitals in their drug disposal.

The Port Hueneme Police Department lobby is open 24 hours a day, 7 days a week.

No paperwork or identification is required for disposal and there is no fee.

## Please note the following items cannot be deposited into the drug collection unit:

- Aerosol cans
- Inhalers
- Hydrogen Peroxide
- Thermometers
- Catheters
- Medical equipment

## The following items will be accepted into the drug collection unit:

- Prescription drugs
- Prescription patches
- Mediations
- Ointments
- Over-the-counter medications
- Vitamins
- Samples
- Medications for pets
- Needles
- o Epi Pens
- o Syringes

#### **Disposal Directions:**

- Place pill bottles/medication in sealed or zipped plastic bag
  - Sealed bags available at front police counter
- o Drop them into the secure bin
- Medication in blister packaging doesn't need to be removed from packaging and can be deposited directly into the bin.
- Liquid medication and ointments shall be placed in a sealed bag and can be deposited directly into the bin
