7. City of Ojai Planning Commission Update

Commissioner Judy Murphy provided the following update:

City continuing to make progress on their RHNA numbers. The project at 510 E. Ojai by the Skate Park is coming to Planning commission. It is proposed to be remodeled with a restaurant and will add two buildings with 13 apartments (5 will be affordable). This is the 2nd time the Planning Commission will review. It will keep the existing façade and the water tower will be brought out front and incorporated into the overall aesthetic/design. Last hearing the Planning commission approved 15 units (apartments) on Montgomery Street. The Planning commission is absent one member, and three members' terms will come up in May.

8. Formal Action Item – Election of Chair and Vice Chair for 2024 year

Chair Cohen announced his resignation from the OVMAC. Supervisor LaVere is actively looking for a recruitment.

Elections for Chair and Vice Chair were held.

Member Wright moved to elect Member Malloy as Chair, and Member Kennedy as Vice Chair. Seconded by Cohen.
