**PHWA RESOLUTION NO. 2024-01**

**A RESOLUTION OF THE WATER AGENCY OF THE CITY OF PORT HUENEME, CALIFORNIA, AMENDING AND ADOPTING A CONFLICT OF INTEREST CODE**

**WHEREAS**, the Port Hueneme Water Agency previously adopted Resolution No. 2022-02, adopting a Conflict of Interest Code; and

**WHEREAS**, the Port Hueneme Water Agency adopted by reference the model Conflict of Interest Code set forth in Section 18730 of the California Code of Regulations; and

**WHEREAS**, the Port Hueneme Water Agency desires to add a position and revise a title of an existing position to the Conflict of Interest Code.

**NOW, THEREFORE, THE WATER AGENCY OF THE CITY OF PORT HUENEME, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:**

**SECTION 1.** Any resolutions in conflict with this resolution including attachments are hereby rescinded and repealed.

**SECTION 2.** The Political Reform Act require (Government Code Section 81000, et seq.) requires state and local government agencies to adopt and promulgate Conflict of Interest Codes. The Fair Political Practices Commission has adopted a regulation (2 Cal. Code of Regulations Section 18730) that contains the terms of a standard Conflict of Interest Code which can be incorporated by reference in an agency's code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730, and any amendments to it duly adopted by the Fair Political Practices Commission, are hereby incorporated by reference. This regulation and the attached exhibits "A" and "B", designating and establishing disclosure categories, attached hereto, constitute the Conflict of Interest Code of the City of Port Hueneme Water Agency. The Port Hueneme Water Agency is considered the "Agency" within the purview of this Code.


**SECTION 3.** Designated employees and officials shall file Statements of Economic Interests with the Clerk of the Ventura County Board of Supervisors (VCBOS); which shall be on file with the Clerk of the VCBOS. The Clerk of the VCBOS shall be and perform the duties of Filing Officer for the Port Hueneme Water Agency. Statements will be available for inspection and reproduction pursuant to Government Code Section 81008.

**SECTION 4.** Any change provided for in this Conflict of Interest Code shall not affect or excuse any offense or act committed or done or omission or any penalty or forfeiture incurred or accruing under any other Conflict of Interest Code, nor shall affect any prosecution, suit or proceeding pending or any judgment rendered in connection with any other Conflict of Interest Code.

**SECTION 5.** That the Agency Clerk and Agency Attorney are hereby authorized to make any typographical, clerical, non-substantive corrections to this resolution as may be deemed necessary.


**SECTION 6.** The Agency Clerk shall certify to the adoption of the Resolution.





The determination of whether a particular consultant has or will have disclosure requirements is to be made in writing. The determination should include a description of the consultant's duties and based upon that description, a statement of the extent, if any, of the disclosure requirements. Each writing, or the combined writing, is a public record and is to be retained for public inspection either in the same manner and locations as the Conflict of Interest Code, or with appropriate documentation at the location where the Conflict of Interest Code is maintained, cross-referencing to the Consultant determination(s).

## EXHIBIT "B"

### Categories of Reportable Economic Interests

#### Designated Persons in Category "1" Must Report:

All investments, interests in real property, income and a business entity in which the person is a director, officer, partner, trustee, employee, or holds any position of management. These financial interests are reportable only if located within or subject to the jurisdiction of the Port Hueneme Water Agency, or if the business entity is doing business or planning to do business in an area subject to the jurisdiction of the Port Hueneme Water Agency, or has done business within an area subject to the jurisdiction of the Port Hueneme Water Agency at any time during the two years prior to the filing of the statement.

#### Designated Persons in Category "2" Must Report:

- A. All investments in real property located within or subject to the jurisdiction of the Port Hueneme Water Agency.
- B. Investments in any business entity that within the last two years has a contracted or in the future foreseeably may contract with the Port Hueneme Water Agency.
- C. Income (including gifts, loans, and travel payments) from any source that within the last two years has contracted or in the future foreseeably may contract with the Port Hueneme Water Agency.
- D. His or her status as a director, officer, partner, trustee, employee or holder of a position of management in any business entity which within the last two years has contracted or in the future foreseeably may contract with the Port Hueneme Water Agency.
