### **Eviction Protections in Effect in Ventura County**

#### • State of California

On March 16, 2020, California Governor Newsom issued Executive Order N-28-20 suspending, until May 31, 2020, any provision of state law that would preempt or otherwise restrict a local government's exercise of its police power to impose substantive limitations on residential or commercial evictions, including but not limited to Civil Code sections 1940 et seq. or 1954.25 et seq., resulting from substantial financial hardship arising from the COVID-19 pandemic.

On March 27, California Gov. Gavin Newsom announced a partial statewide suspension of residential evictions. Newsom's executive order halts residential evictions until May 31 if a tenant cannot pay rent either due to health care costs or a loss of income related to the coronavirus outbreak.

At its meeting on April 6, 2020, the California Judicial Council adopted an emergency court rule that effectively stops all evictions, other than those necessary to protect public health and safety, for the duration of the COVID-19 emergency. The rule is applicable to all courts and to all eviction cases, whether they are based on a tenant's missed rent payment or another reason. This new court rule will apply until 90 day after the Governor lifts the state of emergency related to the COVID-19 pandemic, or until it is amended or repealed by the Judicial Council.
