The County will continue to meet and negotiate in good faith with there being three additional meetings currently scheduled with the union.

Commissioner Lazar inquired whether the Commission could receive a copy of the responsive letter written by Matthew Smith. Commissioners Becker and Little stated that it was not necessary to receive or require the County to send any responsive letter to the Commission. However, Mr. Dembowski stated that if the letter was to be made available it would be forwarded to the Commission for filing.

Staff was instructed to receive and file correspondence from attorney Lawrence Rosenzweig dated May 13, 2010, relating to the Union of American Physicians and Dentists.
