- **XI. COMMISSION/STAFF COMMENTS** Update regarding search for additional conflict law advisors; review and potential amendment of contract for outside legal services.

Cheryl Shaw stated that the advertisement for the outside legal counsel would be placed in the November issue of the Ventura County Bar Association's Citations publication and also concurrently for five days in the Daily Journal. She advised the Commission that if any of the Commissioners know of any attorneys who may be interested, they should be told to submit their resumes to the Commission's office by early November.

With regard to the contract which covers outside legal services, Roberto Orellana stated that he would recommend changing the language of the Assignments clause to reflect that work assigned would be at the sole discretion of the Commission. In response to Commissioner Little, Mr. Orellana stated that the compensable hourly rate for legal services rendered could include travel time which is typically included in attorney compensation, however, the Commission was free to adjust the language to reflect whether the rate would include travel time at the hourly rate or at a different rate.

Commissioner Becker stated he did not have an issue with travel time being compensated as long as it was reasonable. Commissioner Lazar expressed in her opinion that the Commission should not discourage good attorneys from applying for the position based on an uncompensated travel time provision in the contract, especially given the fairly low hourly rate of compensation. Mr. Orellana stated that the hourly rate was lower than that of the rate charged by County Counsel and that the rate could possibly be changed with assistance from Human Resources. Ms. Shaw was directed to reply to any inquiries regarding the compensation by indicating it was currently at the governmental rate of \$160.00 per hour but may be subject to negotiation.
