- IV. MINUTES FOR APPROVAL The minutes of the Regular Business Meeting of March 25, 2021 were approved on motion by Commissioner Vandenberg, seconded by Commissioner Lazar.

- VI. **REQUEST FOR HEARING** Lucas Beller (Fire Protection District); Case #21-277-02-01.

Attorney Robert Baumann appeared on behalf of the petitioner and Assistant County Counsel Marina Porche appeared on behalf of the Fire Protection District. There being no opposition to the petitioner's request, on motion by Commissioner Vandenberg, seconded by Commissioner Stewart, the Commission unanimously voted to find the petition sufficient and granted the request for hearing. A hearing date was set for September 23-24, 2021. Mr. Baumann was further directed he could file a request to close the hearing with the Commission's Assistant. VII.
