## Recommendations

**R-OI.** All County dispatch centers identify officers' CIT status on their 911 displays with other specialized training. (FI-10)

Response: The Ventura Police Department currently displays all on-duty patrol officers' specialized training at each dispatch station. That status is updated every shift (three times daily) and is located at every dispatch station. The status is not placed on the CAD screen due to our screen configuration; however, as upgrades become available, we will consider adding the assignments to the screen itself. As configured now, however, every dispatcher knows instantly which CIT-trained officers are available as each call is taken.
