MINUTES OJAI CITY COUNCIL APRIL 24, 2012

Mayor pro tem Blatz called the regular meeting of the Ojai City Council to order on Tuesday, April 24, 2012 at 7:00 p.m. in the Council Chambers of Ojai City Hall, 401 S. Ventura St., Ojai, California.

On the call of the roll the following Council Members reported present: Paul Blatz, Sue Horgan, Carol Smith and Carlon Strobel. Also present were: City Manager Robert Clark, Assistant City Attorney Scott Howard, Ojai Police Chief Dave Kenney, City Engineer/Public Works Director Greg Grant, Community Development Director Rob Mullane, Finance Director Susie Mears and City Clerk Rhonda Basore.

PUBLIC COMMUNICATIONS

Lucas Thayer, Occupy Ojai, voiced his opinions on Human Rights.

Julie Tumamait-Stenslie, Ojai, asked for a Temporary Use Permit fee waiver for a Spiritual Collective Art Festival to be held on July 21 in Ojai.

Suza Francina and Gayle Bertsch, Ojai, voiced their opinions on the dog shooting in Meiner Oaks.

Audra Lucas, Occupy Ventura, thanked the City Council for adopting the Corporate Personhood Resolution.

Kitty Winn, Ojai, stated she did not like the complaint process to report a code enforcement issue. She felt it was unfair to pit neighbor against neighbor.

Dale Hanson, Ojai, asked the City Council to consider passing an ordinance making it mandatory that all pit bull dogs need to be spayed or neutered.

Julie Tumamait-Stenslie, Ojai, asked if staff had reviewed the archaeological survey that was done for the area.

Suza Francina, Ojai, stated the area has a lot of ecological habitats that need to be preserved when developing.

Community Development Director Robert Mullane said an Environmental Impact Report has been prepared and he will provide more information at the May 22 public hearing meeting.

4. Smart Meters Installation Survey

City Manager Robert Clark presented the administrative report,

The following speakers voiced their opinion on the Smart Meters and asked the City Council to place an immediate ban or moratorium on the installation and use of Smart Meters.

Council Member Smith said the ultimate goal of the electric company is to make money for its share holders. She supported passing an ordinance but encouraged the residents to take a stand and participate in protests against Smart Meter installations.

Council Member Strobel asked how many rate payers there were in Ojai and the percentage that have requested to be put on the delay list. She encouraged the residents to contact the Governor and to file a Notice of No Consent to Trespass and Surveillance/Notice of Liability with Southern California Edison.

Mayor pro tem Blatz said it is the duty of the City to protect the health and safety of its residents. He supported directing staff to prepare an ordinance for review but also encouraged residents to do their part by getting on the delay list, participating in protests and/or contacting their legislators.

Council Member Horgan commented she did not see any advantages to having a Smart Meter installed. She felt people should have a choice as to whether or not they wanted a Smart Meter before the meters are automatically installed. She supported directing staff to prepare an ordinance for the City Council's review.

ACTION:

The City Council directed staff to prepare an ordinance for review. The ordinance should have language that permanently bans the installation of Smart Meters. They asked staff to find out how many Smart Meters have been installed and whether or not they are operating.

Arcade Plaza Maintenance Assessment District Engineer's Report for FY 2012/13 5.

Public Works Director/City Engineer Greg Grant presented the administrative report. He indicated the resolution in the packet had the wrong public hearing date listed. He stated the public hearing date is June 12, 2012.
