RE: Grand Jury Report Dated June 7, 2012 Earthquake Safety in the Classroom

Dear Judge O'Neill:

On June 1, 2012, the Ventura County Grand Jury provided the Ojai Unified School District (OUSD) with a copy of their report entitled, "Earthquake Safety in the Classroom," dated June 7, 2012. This report found that schools operated by Ojai Unified School District complied with having a safety and disaster plan, conducted and monitored required emergency drills, and inspected school facilities on a regular basis. However, the District did not meet the recommended basic emergency provisions and supplies. The Grand Jury recommended that OUSD continue to comply with the required emergency plans, drills and facility inspections. In addition, the Grand Jury recommends OUSD purchase and maintain sufficient food, water, communication equipment and medical provisions.

The Ojai Unified School District has reviewed the Grand Jury report and submits its response on the attached specified form as required by your letter from Mr. David H. Gale, Foreman, dated May 31, 2012.

In summary, the Ojai Unified School District agrees with the Grand Jury's finding and recommendations. The District will continue to comply with the required safety plans and emergency drills. In addition, the District will research into purchasing basic emergency supplies including food and water for at least three days for each person.

R-04 Ojai Unified School District should purchase and maintain sufficient food, water, communication equipment and medical provisions as required.

Please note the Grand Jury Report Facts #27 state the emergency organizations <u>suggest</u> that basic emergency supplies should include water and food for at least three days for each person.

The District recognizes that all district staff and students should be prepared to respond quickly and responsibly to emergencies and disasters. The District will research into purchasing basic emergency supplies including food, water and medical provisions. In addition, the District is already in the process of reviewing communication equipment due to the change in the Federal Communication Commission (FCC) license requirement.
