The Honorable David H. Gale, Foreman:

In accordance with California Penal Code 933.05, the City Council offers the following responses for itself and on behalf of the City Manager to the subject Grand Jury Report dated May 16, 2012:

- With regard to the Report's findings, FI-02, FI-03, FI-06 and FI-07, the City Council accepts those findings pertaining to the City of Port Hueneme without challenge or further comment, and acknowledges the Grand Jury has made findings pertaining to other Municipalities of which the City of Port Hueneme has not made an independent review upon which it may accept such findings.
- With regard to the Report's recommendations, R-01 and R-04, the following responses are offered:

Recommendation R-01: The Cities should aggressively pursue the recovery of costs from the individual(s) convicted of graffiti vandalism.

Response: This recommendation has been implemented since 2006.

The City of Port Hueneme has tracked all of the reimbursable fines of graffiti vandals since 2006. Each vandal's reimbursement payments to the City are routinely monitored to ensure the vandal is making timely payments. Based on its cost effectiveness, the City may take the vandal back to court to enforce a judgment if it finds payments are not being made.

Recommendation R-04: The Cities should enlist the assistance of volunteer groups within the County for graffiti abatement. Such groups might include: Sheriff's and Youth Graffiti Removal Incident Team; Keep America Beautiful; and various civic groups.

Response: This recommendation has been implemented.

The City has implemented this recommendation in a variety of ways. Since 2008, and with the financial support of Hueneme Beautiful, the City has purchased graffiti removal kits for distribution to members of the community who wish to assist in graffiti abatement. These kits are distributed at no charge and to date, approximately 400 kits have been distributed.

The City also supplies more extensive removal kits to City field staff where they also perform graffiti abatement in addition to their regular duties throughout the workday.

The City has also held public graffiti forums at City Hall to exchange information about the graffiti issue, educate the residents and solicit interested citizens to voluntarily assist in abatement.
