RECOMMENDATION

It is recommended that the Council authorize the City Manager to approve the response to the Grand Jury Reports titled <u>Graffiti in Ventura County Cities</u> and <u>Vehicle Impound Fees in Ventura County</u>.

SUMMARY

Penal Code 933.05 requires that the Council comment on the findings and recommendations of the Grand Jury pertaining to city government under Council authority.

The Grand Jury produced these reports and made a series of findings and recommendations regarding impound fees and graffiti both countywide and specifically for the City of Ventura. Attached are our recommended responses.

DISCUSSION

On behalf of the Council and the City Manager the Ventura Police Department and Public Works Department have reviewed the above Grand Jury Reports and have collaborated on the attached responses for signature by the Mayor. Enclosed please find our Response Form to the Grand Jury report titled <u>Graffiti in Ventura County Cities</u>.

We agree with the report findings.

By way of explanation see our comments below regarding the recommendations:

R-01. The Cities should aggressively pursue the recovery of costs from the individual(s) convicted of graffiti vandalism. (FI-02, FI-03)

Response: We have an ordinance that allows us to aggressively recover costs for individuals who have either been convicted or found civilly liable under our ordinance.

R-02. The VCOG should schedule a follow-up to the 2007 Graffiti Summit for the purpose of updating and/or completing the roundtable recommendations previously established and to allow participants to share their current "best practices." (FI-OS)

Response: While recommendation 2 does not directly relate to the City of Ventura, we will participate in future collaborations with VCOG with regards to graffiti.

R-03. The VCOG should expand summit participation to include all entities that may experience graffiti damage. In addition to the 2007 Graffiti Summit participants, the following should be included: various volunteer organizations; railroads within the County; public transportation entities; and other special districts in the County. (FI-OS)

Response: While recommendation 3 does not directly relate to the City of Ventura we will participate in future collaborations with VCOG with regards to graffiti.

R-04. The Cities should enlist the assistance of volunteer groups within the County for graffiti abatement. Such groups might include: Sheriff's and Youth Graffiti Removal Incident Team; Keep America Beautiful; and various civic groups. (FI-07)

Response: While we utilize full time employees for graffiti clean up we will seek further volunteer assistance from additional civic groups as recommended.

R-o5. The Cities, with the exception of Port Hueneme and Santa Paula, should amend their city codes regarding graffiti vandalism to include provisions for the city to petition the sentencing court for the delay or suspension of driving privileges for those convicted of graffiti vandalism, as allowed for in the state vehicle code. (FI-o8) [Ref-o7]

Response: We will work with our City Council and City Attorney to evaluate and potentially implement this recommendation. The Police Department shall take the lead in this effort and will begin this process within this month.

On June 18, 2012 the Ventura City Council approved this Grand Jury report response and authorized the City Manager to make this reply. We appreciate the Grand Jury's efforts in looking into this important matter.
