To the Residents of Ventura County:

For the first time, the Ventura County Grand Jury elected this year to produce a totally electronic Final Report, or e-Report. In addition to saving the County the cost of paper, printing and binding of the report, the Final Report is a live document that will be augmented with the required and requested responses of the subjects of the report. Comparing the report to the responses is the best way to evaluate the facts, findings and recommendations made by the Grand Jury. Your 2012-2013 Grand Jury invites you to read the report with the responses and make your own judgments.

The Final Report represents the footprint of the 2012-2013 Grand Jury covering all manner of people, places and things investigated this year in the County and affecting the following:

Every voter;

Every K-12 and community college student;

Every senior citizen;

Every inmate, deputy and medical staff member;

Every resident in all ten cities;

County and municipal fuel pumps;

Every driver in the City of Ventura;

Every library patron; and even

Every oak tree in Thousand Oaks.

Another accomplishment of the 2012-2013 Grand Jury is the approval of a Spanish-language Public Complaint form by the Presiding Judge. Now, for residents who learned Spanish as a first language, the process of filing a complaint with the Grand Jury is easier.

Finally, on behalf of the entire Grand Jury, please consider serving a term on a future grand jury to represent your community and to improve Ventura County for all its residents.

Final Report

The Ventura County Grand Jury is an independent investigative body with two major functions:


- Civil Government Oversight examination of all aspects of county and city government and special districts to ensure that the best interests of county citizens are being served.
- 2. Citizen Complaints investigation of the validity of complaints brought by citizens alleging government misconduct, mistreatment, or inefficiencies.

California Penal Code section 933 directs the Grand Jury to prepare and issue a final report. California Penal Code section 916 requires that all problems identified in the final report be accompanied by suggested means for resolution, including financial, where applicable.



California Penal Code Section 933.05

- (a) For purposes of subdivision (b) of Section 933, as to each grand jury finding, the responding person or entity shall indicate one of the following:
 - (1) The respondent agrees with the finding.
 - (2) The respondent disagrees wholly or partially with the finding, in which case the response shall specify the portion of the finding that is disputed and shall include an explanation of the reasons therefore.
- (b) For the purposes of subdivision (b) of Section 933, as to each grand jury recommendation, the responding person or entity shall report one of the following actions:
 - (1) The recommendation has been implemented, with a summary regarding the implemented action.
 - (2) The recommendation has not yet been implemented but will be implemented in the future, with a timeframe for implementation.
 - (3) The recommendation requires further analysis, with an explanation and the scope and parameters of an analysis or study, and a timeframe for the matter to be prepared for discussion by the officer or head of the agency or department being investigated or reviewed, including the governing body of the public agency when applicable. This timeframe shall not exceed six months from the date of publication of the grand jury report.
 - (4) The recommendation will not be implemented because it is not warranted or is not reasonable, with an explanation therefore.
- (c) However, if a finding or recommendation of a grand jury addresses budgetary or personnel matters of a county agency or department headed by an elected officer, both the agency or department head and the board of supervisors shall respond if requested by the grand jury, but the response of the board of supervisors shall address only those budgetary or personnel matters over which it has some decision making authority. The response of the elected agency or department head shall address all aspects of the findings or recommendations affecting his or her agency or department.
- (d) A grand jury may request a subject person or entity to come before the grand jury for the purpose of reading and discussing the findings of the grand jury report that relates to that person or entity in order to verify the accuracy of the findings prior to their release.
- (e) During an investigation, the grand jury shall meet with the subject of that investigation regarding the investigation, unless the court, either on its own determination or upon the request of the foreperson of the grand jury, determines that such a meeting would be detrimental.
- (f) A grand jury shall provide to the affected agency a copy of the portion of the grand jury report relating to that person or entity two working days prior to its public release and after approval of the presiding judge. No officer, agency, department, or governing body of a public agency shall disclose any contents of the report prior to the public release of the final report.



Protocol Visits and Agency Briefings

The purpose of protocol visits and agency briefings is to educate the Grand Jury to governmental functions of the County, cities, and special districts within the County so the jurors can meaningfully perform their statutory oversight functions. These visits have the benefit of acquainting the Jury with employees and officials of the institutions they will be examining and enabling the jurors to better evaluate the governmental, legal, and environmental conditions under which they are administered.

On occasions protocol visits may be made to relevant institutions outside of the County so that by observation and comparison the Jury can better evaluate the local processes being examined and make informed judgments and assessments of local agencies and departments in comparison with those in other counties.

Also, California Penal Code section 919(b) requires that the Grand Jury visit jails within the County to inspect their conditions and management. Accordingly, the 2012-2013 Grand Jury visited all detention facilities and jails in the County.

The 2012-2013 Grand Jury members visited 19 facilities, agencies and departments within the Ventura County and received 30 agency briefings. In addition, Grand Jury members participated in 2012 General Election and monitored polling stations in Ventura County and "ride-alongs."
