Dear Judge Brack:

The District complies with the applicable sections of the Education Code that require comprehensive school safety plan and related drills. When developing the comprehensive school safety plan, the school site council will consult with local law enforcement to assess procedures, training, communication, and facilities. In addition, the plan will take into account the school's staffing, available resources, and building design, as well as other factors unique to the site.

As a response to the Connecticut incident, the District met with local law enforcement to conduct site assessments and safety strategies for our schools. In addition to their police assessments, the department imcluded detailed school maps in their vehicles, assigned officer school visits and instituted report filings and conversation to be conducted on our sites/parking lots as a sign of more police presence on our campuses.

The District recognizes that students and staff have the right to a safe and secure campus where they are free from physical and psychological harm. The District is fully committed to maximizing school safety and to creating a positive learning environment that includes strategies for violence prevention and high expectations for student conduct, responsible behavior, and respect for others.

In summary, we appreciate the Grand Jury's effort to assist us in recognizing potential areas of recommendations for school safety. The District is committed to review and implement viable options to provide a safe and secure educational environment for students, staff, parents and visitors while on our premises.
