### ATTACHMENT TO RESPONSE TO GRAND JURY REPORT

#### **RECOMMENDATIONS**

The Grand Jury recommends that:

R-01. The Grand Jury recommends that an independent, non-elected County administrator be assigned to oversee the collaborative efforts of all the senior transportation modalities in the County and produce strategies to simplify senior transportation. This administrator would seek consensus with the independent companies and city transportation agencies with a goal of consistency in the areas of availability, acceptability, accessibility, adaptability, and affordability. Further, the administrator would develop an advisory board comprised of senior bus-riding citizens to point out the opportunities for improvements. In addition, the Ventura County Board of Supervisors should be encouraged to ride a bus route once a year to determine needs and the effectiveness of the programs.

Response to R-0I: The Camarillo City Council does not support Recommendation R-0I for two reasons. First, the Ventura County Transportation Commission already has a staff to coordinate the transportation needs in Ventura County including the transportation needs of seniors. Second, there is limited funding for transportation. Therefore, there is no need for an independent, non-elected County administrator to be assigned as proposed in R-01.

R-02. In cooperation with the VCTC and VCAAA, programs should be implemented that are designed to assist senior citizens with transportation within their cities and throughout the County.

Response to R-02: The City of Camarillo will continue to participate in implementing local and countywide programs designed to aid senior citizens as well as other transit patrons. The development of a memorandum of agreement among five public entities in East Ventura County is a current example of a program designed to improve bus transportation.

R-03. The Ventura County Board of Supervisors should allocate specific funding for senior transportation.

Response to R-03: Like other services and programs provided by an individual agency, funding for senior transportation is not unlimited and must be allocated in balance with the overall financial resources available to the agency.

R-04. The VCTC, working with VCAAA, should standardize requirements for participation in the senior transportation programs. They should also publicize the availability of programs that fulfill the transportation needs of seniors.

Response to R-04: In response to the findings in the recent VCTC Ventura County Regional Transit Study, the ten cities and the County are in the process of developing improved transportation programs, including programs for seniors, and for marketing available senior transportation services based upon needs and financial ability as determined by each jurisdiction.

R-05. The VCAAA should plan for increased staffing to accommodate a growing senior population.

Response to R-05: The City of Camarillo defers to the County of Ventura and VCAAA to make decisions on staffing of the VCAAA based upon needs and available funding.
