Public Access to Conflict of Interest Codes

F1-01 – The Grand Jury found that Conflict of Interest Codes for Ventura County and its 10 cities are not easily accessible to the public.

For the County of Ventura, we partially disagree. While there is no direct link on the already-full main County web pages to Conflict of Interest Code, it is easily accessed via searching. Performing a search on either the main or any other County Web Page, using the term Conflict of Interest Code, results in the first search result returned being a link that takes the searcher directly to the Conflict of Interest Code page on the Clerk of the Board's Website. Performing a search using Google using the term Ventura County Conflict of Interest Code, results in the first search result returned being a link that takes the searcher to the Form 700 page on the Clerk of the Board's Website, which also contains a link to the Conflict of Interest Code. (searches performed/confirmed on June 28, 2016)

R-01 – The Grand Jury recommends that the Ventura County Board of Supervisors establish a direct link on the County homepage for public online access to its Conflict of Interest Code.

The main County webs page is extremely full, and is designed in a manner that utilizes the limited space on the home page to facilitate direct access to the most important services directly, and all other information in as few steps as possible. The County of Ventura will partially implement R-01 by adding a link within the Find page, which is accessible on the main County homepage. Using this feature will direct the searcher to the Conflict of Interest Code page in two clicks (one to click on Find, and one to click on Conflict of Interest Code).

(additional information) References – Within the References section of the report, the Grand Jury cites an obsolete (repealed) Ordinance regarding Ventura County's Conflict of Interest Code. The report's attachment Att-01 does not provide the navigation directions used to find the repealed Ordinance, nor does the report state whether or not they were able to find the document(s) that they were seeking.
