FINDINGS

FI-01:

The Grand Jury found that Conflict of Interest Codes for Ventura County and its 10 cities are not easily accessible to the public. (FA-07, FA-10)

Proposed Response to FI-01:

The City Council concurs that the City of Simi Valley Conflict of Interest Code is not readily accessible to members of the public via the City's website. While the City's Conflict of Interest Code has not been requested by members of the public at any time during the preceding four years, it is readily available upon request and can be obtained in person at the City Clerk's Office or emailed to those making such request.

RECOMMENDATIONS

R-02 The Grand Jury recommends that each city council of the 10 cities within Ventura County establish a direct link on its city homepage for public online access to its Conflict of Interest Code.

Proposed Response to R-02:

The City agrees with this recommendation. The City's website will be updated to provide a link to the City's Conflict of Interest Code on the "View/Watch" menu accessed via the "I Want To" button on the City's homepage.
