Pursuant to California Penal Code Sections 933.05 (a) and (b), the City Council of the City of Thousand Oaks provides the following responses to the findings and recommendations included in the above-referenced Grand Jury Report.

### **BACKGROUND**

After receiving a citizen complaint alleging a conflict of interest within a particular government entity, this raised the question of whether each local governing body within Ventura County had established a Conflict of Interest Code as required by law. Additionally, the Grand Jury made the decision to address whether these Conflict of Interest Codes are readily accessible to the public, thereby making government more transparent. The Grand Jury found that elected officials in Ventura County and its ten cities have all adopted Conflict of Interest Codes which meet or exceed State standards. The Grand Jury found that there was a wide variation in the ease of access to the Conflict of Interest Codes. Further, the Grand Jury made a recommendation for the City to implement to further address public access.

#### FORMAT OF RESPONSE

The City Council's detailed response to the Grand Jury Report is set forth in the following pages. The response is ordered in the same manner as the report itself--Facts, Findings and Recommendations. The City Council is required to respond to Finding 01 and Recommendation 02.
