Dear Ventura County Grand Jury Foreman Ludlum:

This letter, along with the completed "Response to Grand Jury Report Form," which is attached and incorporated herein by reference, constitute Ojai Valley Sanitary District's ("OVSD") formal response to the above-referenced Final Report on Independent Districts.

OVSD STATEMENT ON FINDINGS / CONCLUSIONS:

The first item OVSD is listed in the Final Report is for Fact FA-03 and Conclusion C-01, regarding OVSD's not having held public competitive elections since 2016. Since OVSD's elections are on even years (i.e., 2014, 2016, and 2018 et seq.) and an election is scheduled this year in 2018, OVSD meets this election requirement or finding. In 2016, OVSD did not hold an election because both candidates for their respective Board of Director seats ran unopposed or uncontested. Please also know that OVSD follows all statutory requirements for noticing its elections and any open seats on its Board of Directors.

SUMMARY OF OVSD IMPLEMENTED ACTIONS:

In accordance with the R-04 list of eight recommended information items to be added to the existing OVSD internet website, the information identified in numbers R-04.1, R-04.3, R-04.4 & R-04.6 are already on OVSD's website and have been for several years. Portions of the information outlined in R-04.2 [governance structure, including governing board election information and the process for running for a board seat] is also currently on the website, more detailed information about the board election process will be added to fully implement this Final Report recommendation.

Moreover, the OVSD Board approved and adopted OVSD Board Resolution No. 2018-12 (Reserve Policy) on July 23, 2018 and it has been posted on the OVSD Internet Website as of August 6, 2018. This action fulfills what was requested by R-04.5. As stated in OVSD Resolution No. 2018-12, government agency reserve fund policies and procedures are a function of OVSD's statutorily circumscribed role as a sanitary sewer district pursuant to Health & Safety Code §6400 et seq. (i.e., Sanitary District Act of 1923), its capital improvement plans, on-going capital and equipment maintenance, compliance with federal and state environmental standards, and Board of Director-approved fiduciary policies. Reserve funds are especially important for agencies like OVSD which own, operate and maintain the essential public service of a sanitary sewer collection and treatment facility. The OVSD Reserve funds, together with the Board of Director-adopted budget, "pay as you go" conservative fiscal values, asset management plan and rate studies, provide the District with the fiscal ability to avoid spikes in costs, borrowing and interest payment costs, and undue rate increases.

RECOMMENDATIONS YET TO BE IMPLEMENTED BY OVSD:

Information identified in recommendations R-04.7 [most recent Municipal Service Review and annual financial report supplied to State Controller or alternatively a link to the State Controller's website] and R-04.8 [link to the Ventura County Local Agency Formation Commission] are not currently on the OVSD website but can easily be added.
