Final Report Water Availability for Wildfires in Ventura County June 12, 2023 Association of Water Agencies of Ventura County - Letter of Clarification

Dear Honorable Members of the Grand Jury,

This letter of clarification is being forwarded on behalf of the Association of Water Agencies of Ventura County (AWA) to address an erroneous listing in the reference section of the above subject report, specifically <u>References Section 25</u>.

Please note explanation below for report listings: page 6, SF-15. "Contact lists used by Ventura County OES, currently supplied by the Association of Water Agencies, are out of date by two years." (Ref-11, Ref 25) and Ref-25 "Association of Water Agencies, Ventura County, Members Directory, County Water Districts https://www.awavc.org/aboutus/members/20-county-water-districts retrieved May 19, 2023."

For the record as point of clarification, AWA is a non-profit business organization (non-governmental agency). Although we do promote and encourage general communication and cooperation among water agencies, including communication with the Ventura County Office of Emergency Services (OES) for preparedness and response situations; we do not have authority to command such activity. These efforts are based on voluntary participation only.

Additionally, the "Contact lists" and the https link listed in Reference 25 of the report correlates with AWA's 'About Us / Member Directory' and is not provided as an emergency contact list.

AWA does coordinate with the OES to create ongoing forums for meetings to educate and share information on emergency preparedness. AWA does encourage three major water agencies within Ventura County (Casitas MWD, Calleguas MWD, and United WCD) to stand at the helm and volunteer as a representative "upon call" to the Emergency Operations Center when activated for a related incident. AWA does coordinate a volunteer 'Emergency Preparedness' subcommittee of emergency response coordinators from various agencies to meet periodically and discuss emergency preparedness and response to disasters topics.

Finally, AWA Managing Director and Emergency Preparedness Subcommittee Chairs met with the OES staff following the publication of this report to confirm the aforementioned information, and continue acting in goodwill by offering AWA's ongoing assistance and coordination of communication with AWA members/water community by all means possible and as appropriate.
