City of Simi Valley - Responses

Overview

The City's Information Services Division, which has primary responsibility for the Simi Valley Police Department (SVPD) radio system, was not consulted during the design phase of the VCRRS project. On February 15, 2024, the subject of interoperability was discussed during a meeting with the county; this was months after the design was finalized.

Recommendation R-09

The Grand Jury recommends that the City of Simi Valley verify radio interoperability with Ventura County first responders who have adopted the VCRRS by July 2025.

Response to Recommendation R-09

SVPD has the ability communicate with the county's current system, VCRRS is not in production as of the time of this writing.

SVPD will have the ability to communicate with the VCRRS participating agencies provided SVPD receives cooperation from the county and purchases additional licenses from Motorola. Alternatively, the city may be able to patch the systems together but as noticed in the report this is not as efficient. The City will work with the County to create a detailed plan to ensure interoperability testing is performed prior to July 2025.

Finding F-11

The system in use by the City of Simi Valley can only communicate with other Ventura County agencies' dispatch using a "patching" system, which is not as efficient as direct communication.

Response to Finding F-11

This is correct, currently SVPD can communicate on the same channels by patching them into SVPDs channel. Additionally, SVPD has a standalone radio console, which includes all applicable frequencies with neighboring agencies that SVPD needs to monitor and communicate with. These frequencies are integrated and show up on SVPD console stations.

Discussion Ref-10 (Page 4)

The City of Simi Valley has decided to independently upgrade its communication system and will not participate in the VCRRS.

Response to Discussion Ref-10 (Page 4) (disputed)

At the time of this report, The City of Simi Valley has not made this decision.

Discussion Ref-10 (Page 7)

The City of Simi Valley declined to participate in the VCRRS. The City recently upgraded its outdated system with Comm-Line radios rather than Motorola, the radio used in the VCRRS.

Response to Discussion Ref-10 (Page 7) (disputed)

In 2023 the City gathered requirements and issued an RFP to update it's 18-year-old public safety radio system. The City has received responses to the RFP and is currently evaluating the option of joining VCRRS or purchasing their own system. It is anticipated that the City will make a decision by September 2024.

On March 20th, 2023 the City Council approved the purchase of one hundred and eighty (180) APX 8000 portable and fifty eight (58) APX 8500 Motorola radios that have subsequently been deployed to SVPD. These radios are compatible with VCRRS but will require additional licenses and cooperation from the county for configuration to work on the new system.

Simi Valley can communicate with other Ventura County agencies using a dispatch "patching" system, which is not as efficient as direct communication.

The City of Simi Valley plans to install a new communication tower and rehabilitate an existing tower at the city's expense.

Response to Discussion Ref-10 (Page 7) (disputed)

At the time of this report, The City of Simi Valley has not made this decision.

Discussion Ref-10 (Page 7)

Because of its geographical proximity, the city prefers Los Angeles County as its primary interface rather than Ventura County.

Response to Discussion Ref-10 (Page 7)

It is imperative that Simi Valley can interface and have seamless communications with neighboring agencies including Los Angeles Police Department (LAPD), LAPD Air, Metrolink, Ventura County Fire, LA County Fire, Los Angeles Sheriff's Department, Highway Patrol, and other agencies that use a common mutual aid channel.

It is unclear to the how other VCRRS participants will communicate with outside agencies.

If SVPD participates in VCRRS, additional equipment will be required for them to communicate with other agencies.
