Findings Disputed:

F-05: The members of the PTACS Steering Committee which includes the Assessor, Auditor-Controller, Treasurer Tax Collector, CEO, County CFO and County CIO, have monthly meetings to address significant issues and take appropriate action needed. The Assessor is a regular participant and provides all the needed support we can to continue to move the project forward. We are available daily to provide that support.

Recommendations Implemented:

R-01: The internal dashboard has been in place over the last several weeks. It includes types, quantities, and status of all assessment roll corrections and supplementals processed and in process. We are also able to review individual status of a particular parcel number.

Recommendations That Will Be Implemented:

R-02: An online public facing portal is being created for the taxpayers. The taxpayer will be able to access their refund information through a parcel number lookup and it will provide the status of that refund by department. The system will be able to access the history back to 2023 which is when Orbit came online. The completion date is planned for 10/31/2025.

R-04: Since this recommendation is addressed to the Auditor-Controller and Treasurer-Tax Collector, the Assessor will respond by supporting this recommendation of implementing a manual process to refund property taxes.

Recommendations That Will Not Be Implemented:

R-03: The Assessor has always provided adequate internal and external resources to the Oasis platform and will continue to do that into the future. Since the Assessor went live with Oasis in October of 2021, we have been successfully using Oasis to perform the Assessor's duties. All assessment information needed, from the Assessor's Oasis system, is available to the Auditor-Controller and Treasurer-Tax Collector to process property tax refunds.
