B. Toland Park

Lubin states that she is working with the Ride Heritage Valley organization, an off-road bicycling group that's interested in using Toland Park as an off-road bicycle recreation area. Ride Heritage Valley is working with other groups including the International Biking Association, which will study the use of Toland Park for this purpose. Mark Langston of Ride Heritage Valley is present to answer questions. The Parks Department supports this use of Toland Park, as the park is under utilized.

A. Rent & Fee Schedule

The Parks Department Rent & Fee Schedule was presented to the PAC for consideration. Van Dyck answered general questions regarding increases and decreases to permit and camping fees.
