#### **STATEMENT OF UNDERSTANDING**

understand I am responsible for knowing and complying with all Local laws and regulations governing commercial cannabis business in Ventura County pursuant to Ventura County Cannabis Regulations ("VCCR") Chapter 5, Article 1 Licensing of Cannabis Operations, to establish standards and regulations for commercial cannabis uses. I understand I am being made aware of the following laws and regulations and agree to comply with them, and all other applicable laws and regulations, upon issuance of my business license (initial)
understand and acknowledge that all commercial cannabis activity shall comply with applicable State laws and regulations, as may be amended including all license, approval, inspection, reporting and operational requirements imposed by the State and its regulatory agencies having urisdiction over commercial cannabis activity. (VCCR 2702(a)(2)) (initial)
understand and acknowledge that the County shall not renew a cannabis business licenses if the licensee is not complaint with this Chapter. (VCCF 2704(e)) (initial)
understand and acknowledge that an applicant shall submit to the County Executive Officer an application for a cannabis business license with al required documents, plus as many copies of the application and supporting documentation as required, and the application fee, pursuant to Section 2712, using the method and location for submission as determined by the County Executive Office. (VCCR 2705(d)) (initial)
understand and acknowledge that whenever any individual, corporation, limited liability company, partnership or other type of business entity icensed under this Chapter sells or transfers any part greater than ten percent (10%) of its corporate stock, partnership interest or other business interest in a commercial cannabis operation, a new cannabis business license shall be obtained pursuant to Section 2704 of this Chapter. (VCCF 2714(b)) (initial)
understand and acknowledge that a licensee shall not change or alter the premises in a manner which materially or substantially alters the premises, the usage of the premises, or the mode or character of the business operation conducted from the premises, from the site plan or other plans on file with the application, unless and until the licensee obtains written approval by the County Executive Office. (VCCR 2715(a))
understand and acknowledge that throughout the term of the cannabis business license, each and every licensee shall comply with this Chapter the County Code, and State law. (VCCR 2716(a)) (initial)
understand and acknowledge that the licensee shall continuously operate of all required odor control prevention devices and techniques for cannabis cultivation. (VCCR 2716(a)(3)) (initial)
understand and acknowledge that the licensee shall be responsible and liable for safety and security in and around the commercial cannabis operation and shall provide adequate security on the premises including the cleanup of graffiti, trash around the premises within forty-eight (48) nours. (VCCR 2716(a)(5)(A)) (initial)
understand and acknowledge that the licensee must legally hold all required State licenses under the Medicinal and Adult-Use of Cannabis Regulatory and Safety Act (Business and Professions Code §§ 26000, et seq.), as may be amended, and under all other applicable State laws. (VCCF 2716(a)(9)) (initial)
understand and acknowledge that County officials may enter the licensee's premises during standard operating hours for the purpose of observing compliance of the commercial cannabis operation with this Chapter. (VCCR 2716(b)) (initial)
understand and acknowledge that it is a misdemeanor for any person having any responsibility over a commercial cannabis operation to impede obstruct, or interfere with an inspection, or the review of the copying of records and monitoring (including recordings) including, but not limited to the concealment, destruction, and falsification of any recordings or records. understand and acknowledge that it shall be unlawful for any person to violate any provision, or to fail to comply with any of the requirements, of this Chapter. Any person violating any of the provisions or failing to comply with any of the mandatory requirements of this Chapter shall be guilty of a middle group of the provision of the provisi
