Dear Mr. Hurst and Ms. Margolis,

This letter outlines Bridges Charter School's response to the Ventura County Grand Jury's Report dated April 2, 2020. The following are our responses to the additional inquiries posed:

- 1. Bridges Charter School has approved an amended board policy and procedure dated 6-15-2020. Please see attached policy BP 6142.1. Although our original response stated our intent to adopt a new board policy on January 13, 2020 we have since amended this policy adopted on 1-13-2020 to reflect changes and updates to meet state guidelines as outlined in the grand jury report.
- 2. In our original response we stated we have adopted the *PROTECT* Curriculum in response to AB 329 and AB 1227. In addition, we offer a Comprehensive Sexual Health program and HIV/AIDS Prevention Education Program as outlined by the state under the California Healthy Youth Act. We have recently purchased a new full curriculum called *Positive Prevention Plus* and will be implanting this curriculum in the fall of 2020. *Positive Prevention Plus* is a comprehensive evidence-based sexual health and teen pregnancy prevention curriculum for grades 7-12 and out-of- school youth, written in compliance with the updated California Education Code including "The California Healthy Youth Act" (AB 329) and "Sexual Harassment and Violence Instruction" (SB 695) and the National Health Education Standards.

Given both curriculum are purchased copy written materials we do not feel it would be appropriate or within legal guidelines to place the entire curriculum online but instead have opted for an overview. However, we will have a copy in our school office for preview.

## #4. Through #7.

Parents are provided an electronic copy of our Family Handbook and made aware of our policies that are publicly available on our website. In addition, we send a letter to parents and guardians in alignment with Ed Code Sections 51240 and 51937-51939 with the purpose of informing parents and guardians of our Comprehensive Sexual Health Program and HIV/AIDS Preventative Education. Parents are informed of their right to request that students(s) be excused from all or part of the Sexual Health Education and/or Surveys. (See attached) In the notification given to 7<sup>th</sup> grade parents or guardians parents are:

- provided an overview handout of the curriculum as well as the opportunity to preview the curriculum in the front office
- asked to sign and acknowledge participation in curriculum and/or surveys
- given an option to opt out of all or part of the curriculum/surveys
- notified the student will not receive any academic penalty for opting out
- informed of optional curriculum offered and provided with instruction and materials
  that align with "negotiation and refusal skills to assist pupils in overcoming peer
  pressure and using effective decision making skills to avoid high-risk activities.' See

- provided access to preview the student survey

Bridges Charter will provide students in grades 7 with a Comprehensive Sexual Health program and HIV/AIDS Prevention Education as outlined by the state under the California Healthy Youth Act to include 5 primary purposes:

- Provide pupils with the knowledge and skills necessary to protect their sexual and reproductive health from HIV and other sexually transmitted infections and from unintended pregnancy;
- Provide pupils with the knowledge and skills they need to develop healthy attitudes concerning adolescent growth and development, body image, gender, sexual orientation, relationships, marriage, and family;
- Promote understanding of sexuality as a normal part of human development;
- Ensure pupils receive integrated, comprehensive, accurate, and unbiased sexual health and HIV
  prevention instruction and provide educators with clear tools and guidance to accomplish that
  end;
- Provide pupils with the knowledge and skills necessary to have healthy, positive, and safe relationships and behaviors.

## Furthermore Bridges Charter shall align with the following mandate:

- Bridges Charter will provide a parent/guardian notification of the curriculum and surveys on sexual health and human trafficking that includes a separate, easy-to-use opt out form for parents/guardians to sign and return at the beginning of the school year or upon enrollment for 7th grade families.
- A parent/guardian may request in writing that his/her child be excused from participating in all or part of the HIV/AIDS prevention or sexual health education and/or survey.
- The student will not receive any academic penalty. Alternate educational curricula will be provided on "negotiation and refusal skills to assist the pupil in overcoming peer pressure and using effective decision making skills to avoid high-risk activities."
- Written and audiovisual educational materials used in comprehensive sexual health education and HIV prevention education will be made available for inspection in the school office upon request.
- The comprehensive sexual health education or HIV prevention education will be taught by school personnel.
- Comprehensive sexual health and HIV prevention education are both mandated instruction and shall occur once in middle school and once in high school. The EC defines comprehensive sexual health education as "education regarding human development and sexuality, including education on pregnancy, contraception, and STIs" and HIV prevention education as "instruction on the nature of HIV and acquired immune deficiency syndrome (AIDS), methods of transmission, strategies to reduce the risk of HIV infection, and social and public health issues related to HIV and AIDS."
- Abstinence may not be discussed in isolation. The EC requires that instruction and materials include information that abstinence is the only certain way to prevent HIV, other STIs, and unintended pregnancy. However, it also states: "Instruction shall provide information about the value of delaying sexual activity while also providing medically accurate information on other methods of preventing HIV and other STIs and pregnancy." "Abstinence-only" sex education, which offers abstinence as the only option for preventing STIs and unintended pregnancy, is not permitted in California public schools.
- All instruction and materials must support and align with the purposes of the California Healthy Youth Act and with each other. Instruction and materials may not be in conflict with or undermine each other or any of the purposes of the law. For example, schools may not use materials that, in promoting abstinence, focus exclusively on the failure rates or perceived disadvantages of condoms or contraception.

The Bridges Charter School's Governing Board recognizes that the purpose of the school's sexual health and HIV/AIDS prevention instruction is to provide students with the knowledge and skills necessary to protect them from unintended pregnancy and sexually transmitted infections and to encourage students to develop healthy attitudes concerning adolescent growth and development, body image, gender roles, sexual orientation, dating, marriage, and family. The Board therefore desires to provide a well-planned sequence of instruction on comprehensive sexual health and HIV/AIDS prevention.

Bridges Charter will provide students in grades 7 with a Comprehensive Sexual Health program and HIV/AIDS Prevention Education as outlined by the state under the California Healthy Youth Act to include 5 primary purposes:

- Provide pupils with the knowledge and skills necessary to protect their sexual and reproductive health from HIV and other sexually transmitted infections and from unintended pregnancy;
- Provide pupils with the knowledge and skills they need to develop healthy
  attitudes concerning adolescent growth and development, body image, gender,
  sexual orientation, relationships, marriage, and family;
- Promote understanding of sexuality as a normal part of human development;
- Ensure pupils receive integrated, comprehensive, accurate, and unbiased sexual health and HIV prevention instruction and provide educators with clear tools and guidance to accomplish that end;
- Provide pupils with the knowledge and skills necessary to have healthy, positive, and safe relationships and behaviors.

#### **POLICY DETAILS:**

1. Goals for the Bridges Charter School's health education program shall be designed to promote student wellness and shall include, but not be limited to, goals for nutrition education and physical activity.

2. The Director or designee shall provide periodic reports to the Board regarding the implementation and effectiveness of the school's health education program which may include, but not be limited to, a description of the school's program and the extent to which it is aligned with the state's content standards and curriculum framework, the amount of time allotted for health instruction at each grade level.

## Parent/Guardian Consent

- 1. The law prohibits active consent for any part of comprehensive sexual health education or HIV prevention education. Passive (not active) parent/guardian notification is required for comprehensive sexual health education and HIV prevention education, either at the beginning of the school year or at least 14 days prior to instruction. Bridges will send a letter 14 days prior to the curriculum being presented in the class which will include a link to materials in which parents can preview.
- 2. A parent/guardian may request in writing that his/her child be excused from participating in HIV/AIDS prevention or sexual health education. Students so excused by their parents/guardians shall be given an alternative educational activity. (Education Code 51240, 51939)
- 3. A student shall not be subject to disciplinary action, academic penalty, or other sanction if the student's parent/guardian declines to permit the student to receive the instruction. (Education Code 51939)

This letter is to inform you of your right to request that your student(s) be excused from the family life unit due to personal or religious beliefs. These rights are included in the California Education Code Sections 51240 and 51937-51939 but do not apply to descriptions or illustrations of human reproductive organs which may appear in a textbook adopted pursuant to law on physiology, biology, zoology, general science, health, or personal hygiene.

In response to AB 1227 Bridges Charter School is required to teach California's school-age population how to avoid becoming victims of exploitation, help them understand the problem of human exploitation and learn ways to address the problem through service initiatives. At least once in middle school, 7<sup>th</sup> grade being the target group, we will provide instruction to students on human trafficking including:

- The prevalence, nature, and strategies to reduce the risk of human trafficking
- Techniques to set healthy boundaries
- How to safely seek assistance

The curriculum used will be from the PROTECT Program http://protectnow.org/our-program-2/

The middle school curriculum (appropriate for ages 11-14) used will be based on:

### Protecting a Masterpiece

This lesson builds upon the concept of the inner voice, introducing the establishment of boundaries though use of words, body language, time, and physical space. It includes the importance of emotional pauses and an emphasis on responding to their gut feeling.

The students are taught about the many forms that child abuse can take (physical, emotional, neglect, sexual), and that there are also different types of human trafficking, such as forced labor or commercial sexual exploitation.

Optional Components for Elementary grade (ages 4-11) are:

#### Safe People, Safe Places, Safe Choices

This lesson establishes foundational concepts critical to ending human trafficking, focusing on equipping students with tools to develop personal boundaries that will help keep them physically and emotionally safe, both online and in-person.
